ALL COMPANIONS MUST HAVE UP TO DATE VACCINATIONS. OWNERS MUST PROVIDE WRITTEN PROOF OF THEIR COMPANION'S DHLPP, RABIES, AND BORDATELLA (KENNEL COUGH).

COMPANION MUST BE SPAYED OR NEUTERED

OWNERS MUST CERTIFY THAT THEIR COMPANIONS ARE IN GOOD HEALTH AND HAVE NOT BEEN ILL WITH A COMMUNICABLE CONDITION IN THE LAST 30 DAYS. DOGS WHO HAVE BEEN ILL WILL REQUIRE VETERINARIAN CERTIFICATION OF HEALTH TO STAY AT FOREVER FRIENDS.

WE CANNOT ACCEPT COMPANIONS THAT HAVE HARMED OR SHOWN AGGRESSIVE BEHAVIOR TOWARDS ANY PERSON OR OTHER DOG.

FEEDING INSTRUCTIONS:

TERMS AND CONDITIONS

This is a legally binding contract between Denise Hall d/b/a FOREVER FRIENDS COMPANION ANIMAL SERVICES ("Forever Friends") and the pet owner whose signature appears below (hereinafter called "Owner"), pursuant to the following "terms and conditions" as set forth herein.

1. Owner agrees to pay the rate for boarding in effect on the date Companion is checked into Forever Friends. And further agrees to pay all costs and charges for special services requested and all veterinary costs for the Companion during the time said Companion is in the care of Forever Friends.
2. Owner agrees that the Companion shall not leave Forever Friends until all charges are paid to Forever Friends by the Owner.
3. The Owner represents and warrants that all the information provided to Forever Friends is accurate and correct, and that Owner has disclosed all facts material to the animal and its stay at Forever Friends, whether or not directly asked about in this contract.
4. The Owner of the within named animal specifically represents that he or she is the sole owner of said animal and that there is not now any lien or mortgage against said animal.
5. The Owner specifically represents to Forever Friends that the Companion has not been exposed to rabies, distemper, or has been ill within a thirty-day period prior to boarding.
6. All charges incurred by the Owner shall be payable upon pick-up or delivery of Companion and when billed by Forever Friends at address listed on the contract. Forever Friends shall have, and is hereby granted, a lien on the Companion for any and all unpaid charges resulting from boarding and other services provided to the Companion by Forever Friends. The Owner agrees that in the event any charges are not paid when due in accordance with this contract, Forever Friends may exercise its lien rights upon ten days written notice given by Forever Friends to the Owner by certified mail to address shown on contract. Forever Friends may use the Companion as compensation for any and all unpaid charges. If such sale shall not secure a price adequate to pay boarding costs and other delinquent charges, plus all costs incurred in the collection of these charges, including reasonable attorneys' fees, then Owner shall be liable for the difference. Any bounced checks will be charged an additional fee of \$25.00 and the whole amount must be paid in cash or cashier's check.
7. Forever Friends shall exercise reasonable care for your Companion while she or he is with us. Forever Friends does not assume and shall not be held responsible for any liability with respect to the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal,

or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of Forever Friends or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said animal at any time within the term and time of the contract. Forever Friends will not be responsible for any fleas or ticks noted on the animal after ten minutes of leaving the premises. The responsibility and/or liability of Forever Friends in no event shall exceed the sum of One Hundred Dollars (\$100.00) and the undersigned agrees to limit the responsibility to One Hundred Dollars (\$100.00) for any and all damages sustained or suffered by reason of the boarding of this animal and Forever Friends to the sum of One Hundred Dollars (\$100.00) and no more, and agrees not to claim any damages against Forever Friends of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum.

8. If the animal becomes ill, or if the state of the animal's health otherwise requires professional attention, Forever Friends may, in its sole discretion, engage the services of a veterinarian (either the Companion's or one in close proximity to Forever Friends), administer medicine, or give other requisite attention to the animal and the expenses thereof shall be paid by the Owner.
9. This contract is governed by and shall be interpreted pursuant to the laws Florida; and any action brought related to this contract shall be filed the courts in and for Hillsborough County, Florida, and the prevailing party shall be entitled to recovery of reasonable attorneys' fees and costs.
10. This Contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, personal representatives, and assigns of the owner of the within named animal.
11. The unenforcability of any portion of this contract shall not affect the unenforcability of any other portion of this contract; and any portion of this contract not enforced shall not constitute a waiver said portion or any other portion of this contract.
12. Additional Terms and Conditions incorporated herein by reference. Any additional term inconsistent with the above shall be unenforceable. The Company and the Owner hereby agree to the following additional terms:
